**Entries:** \$25.00 Office Fee per entry (incl. \$1 admission). USDF/USEF Cards for incomplete entries will be printed for fee of \$10.00. Class fees- Intro: \$30.00, Training: \$35.00, First/Second: \$40.00, Third/Fourth/FEI/Freestyle: \$45.00. GAIG/USDF Qualifying classes please add \$10.00 to entry fee for each qualifying test and include copies of horse's USDF & USEF registrations. Freestyle rides, please specify level and include copy of qualifying test. Opportunity Classes are for entry level riders; cross entry w/other classes is allowed. Horses and riders participating only in Opportunity Classes are exempt from USEF and USDF membership/ non-member fees, drug fee and Horse Identification (HID) requirements. If horse or rider does have HID or membership numbers, they must be listed on the entry form. All entries must be mailed to secretary or submitted online via <http://www.equestriantentries.com> and must be accompanied by payment. Draw checks to "NWDA." Credit cards accepted for online entries only. **Refunds: Full refund less office fees available prior to closing date. After closing date no refunds other than USEF/USDF fees for any reason.**

**Late Entries:** \$35.00 if not postmarked by closing date. Entries will not be accepted without payment. Class adds/changes after closing date only if scheduling allows, for a fee of \$5.00 per add/change. Change of horse/rider after closing date \$20.00.

**Stabling/Tack Fees:** Stall deposit required for each entry, \$25.00 per entry, to be refunded after management ok's clean stall. \$100.00 from Friday to Sunday per horse. \$75.00 for weekend tack stall. \$50.00 per day or portion thereof for either horse or tack stall. Permanent and temporary stalls with doors, on the show grounds. No bedding provided. Shavings may be ordered on entry for \$8 per bag or purchased at the show while supplies last. Please indicate stallions and special requests on the entry form. Some stalls may be 8'x8'-please indicate on entry if larger stall required. All horses must be stabled; no jump-outs. Stabling is available after 3pm the day before the show. Please plan your arrival accordingly. Special requests honored on a first-come, first-serve basis.

**Non-compete/Schooling Fee:** \$20.00 per calendar day for horses on grounds and not competing. Must submit entry form and coggins, and pay office fee and stabling.

All entries must include (*Items 1 thru 4 do not apply to entries with only Opportunity Classes or Intro*)

- 1) Copy of current USEF membership card(s) for owner, rider, and trainer (indicating Amateur status for Amateur classes) or non-member fee(s).
- 2) Copy of rider's & owner's USDF membership or non-member ID number & fee.
- 3) Copy of horse's USDF HID or Lifetime Registration card.
- 4) Copy of USEF & USDF registrations for Qualifying classes. Rider and owner must be USEF members for Qualifying classes.
- 5) Copy of Current Negative Coggins, taken during current calendar year. Horse's name on coggins must be the same as on the entry form.

**Ride times:** Preliminary ride times will be posted to [www.foxvillage.com](http://www.foxvillage.com) and emailed to competitors by the Wednesday prior to the show. Show management not responsible for illegible email addresses on entries- *please write clearly*. Final ride times will be posted on show grounds 24 hours prior to start of competition. Riders are responsible for informing management of any time conflicts as soon as possible after receiving preliminary times.

**Footing:** All classes will be held in outdoor rings with sand footing. Warm-up areas are sand footing or grass over sand. **Awards:** Trophy, ribbons to 6<sup>th</sup> place. Classes may be split or combined if entries warrant. **Accommodations:** Lumbermen's Inn (Iron River): 715-372-4515, The Red Motel (Iron River): 715-372-8770, Rustic Roost (Iron River): 715-372-4426, Brule River Motel (Brule): 715-372-4817. **Directions:** I-35 North to Highway 2 East (exit 253A). Cross bay into Superior, WI. Turn left at stoplight. Follow Highway 2 (Belknap St) to Barker's Island. Turn right at junction of Highways 2 and 53. Follow Highways 2/53 out of Superior. Hwy 53 will split off to the right/South. Take Hwy 2, the LEFT split and continue to follow Hwy 2 through Wentworth, Poplar, and Brule. Before the Town of Iron River, there is a lake on the right and a sign on the right hand side of the road that says, "fairgrounds." Turn left and follow to fairgrounds, approx. ¾ mile. **Other:** All dogs must be leashed. Returned check fee of \$30. No smoking in stall areas, show office or other buildings. Food available on grounds during limited hours.
